The Apothecary is a Patient-centered pharmacy practice providing personalized medicine and service that we hope makes a positive difference in your life.

You may have noticed that our pharmacy, with its state of the art compounding laboratory, has a different appearance than other retail pharmacies. Our lab is necessary as we specialize in prescription compounding, which allows our pharmacists and staff to provide the customized medication required to meet your individual health and medical needs.

Your practitioner has prescribed a prescription for **Low Dose Naltrexone (LDN)**. LDN is a compounded medication that has shown benefits for a broad spectrum of health conditions: ranging from inflammatory, autoimmune, pain, and mental health issues; to dermatologic and gastro-intestinal disorders.

We realize that every human being and animal (veterinary) has a unique physical and mental make-up; and **a one-size-fits-all approach does not work for many people**. The most effective dose of LDN for any one person is very individualized, some respond better clinically at lower doses, some require a higher dose for more favorable outcomes.

The Apothecary's pharmacists, together with your medical practitioner, will evaluate your clinical progress while taking LDN, and make the proper adjustments until your ideal dose is reached. Typically, the dosing starts low and is tapered upward until you experience the most favorable response. That becomes your dose. In the future, further dosage adjustments may be necessary as your clinical picture is changing (improving).

Our goal is to take the time to get to know you and your condition and be an integral part of your path to better health. It is extremely important in the early months of therapy to follow up with our pharmacists regarding your dosing. We will be gathering your symptom picture to share with your practitioner to help them assess your clinical progress. It is this critical stage where your input is essential in helping us determine your most beneficial LDN dose needed for successful healing. Routinely filling out the symptomology spread sheet provided, rating your symptoms on a scale of 0 to 5, is the best tool we have to track your progress.

Some may respond favorably, in some degree, to LDN within weeks, and others will require a little more time and patience, possibly 4-6 months. Our pharmacists and staff at The Apothecary are here to guide and assist you throughout your LDN health journey

Call your doctor if:

- ♦ You experience any side effects.
- ◆ You are taking additional medicines that may interact with this compounded medicine.
- ◆ You have allergies or other medical conditions that should be noted.

- ♦ Information on the label is not clear to you.
- ◆ You have any concerns regarding precautions, ingredients, or proper storage.

Our pharmacists will be happy to help with any additional questions or concerns.
